# RELAXED 4 DAY ITINERARY

Participants are free to book different airlines and flight times among the several daily nonstop options from NY Airports. All participants arriving on February 10 and departing on February 13 are provided with airport transfers. Note: if you divert from the suggested flight itinerary and arrive to Jamaica late on February 10 or depart early on February 13, you may miss out on certain group activities or meals.*

## Day 1 Thursday, February 10

**7:20 am** - **United 2126\*** departs Newark

International Airport (EWR) *\*Recommended Flight*

**11:19 am** - Arrive Montego Bay's Sangster International Airport (MBJ).

From the airport we take the coastal route towards Montego Bay's historic **Hip Strip** with spectacular views of the Caribbean Sea. We stop for our Welcome Lunch at **Marguerites**, the award-winning Jamaican fine dining and "sea-to-table" restaurant.

In this tremendously popular corridor of Montego Bay, we get a glimpse of the country's huge developments in tourism. But our visit to Montego Bay is brief, and we say '**Lickkle more**' to the crowds - one of the Jamaican *Patios* phrases meaning see 'you later' or 'goodbye,' as we depart for **Treasure Beach** (approx 2 hour drive with pit stops).

### Afternoon

As we arrive to the South Shore of Jamaica we pass through **Black River**, capital of the St. Elizabeth Parish, and gateway to Treasure Beach. Time permitting, we make a quick stop at the famous stick-built **Pelican Bar** to knock back an ice-cold Red Stripe or fruit juice and see the assortment of memorabilia left by tourists world-wide.

### Welcome to Treasure Beach

Treasure Beach is located on the quiet and peaceful South Coast of Jamaica, removed from the crowded Jamaican resort areas. In the 19th Century, the South Coast of Jamaica was inhabited

by shipwrecked Scottish sailors. Many of their descendants—with red skin, red hair and blue-green eyes—populate this area of the island. The South Coast spirit is just as distinctive. Fishermen and farmers from these parts are as well-known for their friendly ways as for their intimate knowledge of earth, sky and sea. In Treasure Beach we find the **charm of Old Jamaica** and Southern hospitality in true Jamaican form.

Arrive Treasure Beach. Hotel Check-in.

Before dinner, enjoy time to rest and soak in the sunset views from our hotel or on the beach.

#### Secluded Beach getaway and King Fish Cookout

With our very own Captain and storyteller, we travel by boat to a private beach and cook a sumptuous lunch of fresh kingfish, lobster, vegetables and other delicacies over an open fire. A thatch-covered canopy, and plenty of cold drinks, provide a welcome respite from the Caribbean sun and heat. If we're lucky we may have dolphin sightings!

#### Visit the Appleton Rum Estate

The largest and oldest distillery in Jamaica, Appleton Estate is set in the delightful Nassau Valley of St. Elizabeth. It was established in 1749, however, many believe the origins of the Estate date back to 1655. From trips taking the rum to England, to trying to turn the drink into a whisky substitute during World War II, Appleton's experiments have created a signature taste for their now famous liquor. With master blender Joy Spence at the helm (the first woman in the world to hold that title) Appleton's rum has reached a point of near perfection. This distillery's recent renovation makes this Rum distillery tour one of the best in the world.

#### YS Waterfalls

On this optional tour, we depart for the **Santa Cruz Mountains** where we visit one of the most scenic waterfalls in Jamaica. On our way back to Treasure Beach, there is an opportunity to visit the town of Black River for a brief shopping opportunity and to learn about the local history and heritage.

### Afternoon

Enjoy our last sunset on the South Shore.

### Evening

Group Dinner, live music and entertainment.
